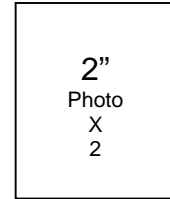

1. The above-mentioned fee per person is based on 4-peolpe-sharing-room. An extra US\$220 per person will be charged for the twin sharing . Those who would like to book for twin sharing rooms, please request in advance as there are limited rooms (capacity of 12 people only). Allocation will be on a first come first served basis (based on receipt of full payment of fees).
2. **Repeater\* :** Those who have completed AOL Sri Sri Yoga Ph1 & Ph2 or fully qualified Sri Sri Yoga Teachers are eligible for the repeater's rates. Those who have only completed Sri Sri Yoga TTC Ph1 or express SSY TTC (and are not yet qualified Sri Sri Yoga teachers) are requested to take full training course and not regarded as repeaters.
